- 2. THIS COURT ORDERS that the Respondent, GoDaddy Inc. and GoDaddy.com LLC, shall forthwith disclose to and produce to the Applicants all documents it has in its possession with respect to <a href="www.maureencassidy.ca">www.maureencassidy.ca</a> and <a href="www.virgniaridley.ca">www.virgniaridley.ca</a>, including the Domain Information, Custom DNS Entries, Contact Audit History, and Purchase Receipts.
- 3. THIS COURT ORDERS that the Respondents A Medium Corporation and Wix.com Inc. shall forthwith disclose to and produce to the Applicants All information in the person's possession, power or control regarding the identity of and contact information for the individual(s) who registered and purchased the domain names <a href="https://www.virginiaridley.ca">www.virginiaridley.ca</a> and <a href="https://www.maureencassidy.ca">www.maureencassidy.ca</a>, and who purchased any website building services for the above websites, and who purchased any webhosting services for those websites, including, without limiting the generality of the foregoing, the name(s), address(es), Internet protocol address(es), email address(es), telephone number(s) and names associated with the credit card or any other payment service used for the aforementioned registration and purchases.

4. THIS COURT ORDERS that the Respondent Facebook Canada Ltd., shall forthwith disclose to and produce to the Applicants all documents in its possession, power or control, regarding the identity and contact information for the individual(s) who registered, created, or was the administrator for the Facebook pages, "The Truth About Virginia Ridley" and "The Truth About Maureen Cassidy".

5. This west orders that the applicants reinburge the respondents for their reasonable out-of-pocket expenses and shad they are communicated and shad to share production or set by this court in the event of dischargement.
